

## BENEFIT UNIT SUBSCRIPTION

This agreement entered into between the HUGHES COUNTY, OKLAHOMA, RURAL WATER DISTRICT #6, a non-profit corporation, hereinafter called the "District", and \_\_\_\_\_, member(s) of the Association, hereinafter called "Member".

### WITNESSETH

Whereas, the Member desires to subscribe and purchase a Benefit Unit as provided by Article 6 of this District By-Laws, and thereafter enter into a water users agreement as required by the By-Laws of the District, and

Whereas these parties desire to memorialize member(s) commitment to subscribe to a Benefit Unit and stipulate that the consideration paid for a Benefit Unit shall be considered a donation to the District which shall in no event and under no circumstance be refunded to the member, except in case of impossibility of providing water service.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, it is hereby understood and agreed by the parties hereto as follows:

The District shall furnish, subject to the limitation as determined by the feasibility of the water system and set out in its By-Laws and Rules and Regulations now in force or as hereafter amended, such quantity of water as Member may desire in connection with Member's occupancy of the following described property:

The Member agrees to grant to the District, its successors and assigns a perpetual easement in, over, under and upon the above described land, with the right to erect, construct, install, and lay and thereafter use, operate, inspect, repair, maintain, replace, and remove water pipelines and appurtenant facilities, together with the right to utilize adjoining lands belonging to the Member for the purpose of ingress to and egress from the above described lands.

The Member agrees to execute that standard Water Users Agreement as found in OK Instruction 1942-A Guide 2, page 1-6, which document has been explained prior to the execution of this agreement.

The parties further agree that if the District water system is unable to provide a service connection to this subscribing Member because the system does not extend to the Member's property, then in that event Member shall be entitled to a refund of the consideration paid for a Benefit Unit, notwithstanding any other provision of this agreement.
